## Objection to Planning Application 55318/001 Due to Public Health Concerns

Dear Samantha Owen,

I am writing to submit an extended objection to planning application 55318/001 for the proposed development at Land west of Beechlands Road, South Medstead, Alton. This objection is based on significant public health concerns related to the continuous state of development in the area, particularly following the recent completion of Phase One by Bargate Homes in 2019 and the COVID-19 pandemic.

## **KEY Public Health CONCERNS**

Mental Health and Well-being

**Stress and Anxiety:** Continuous construction activities lead to heightened stress and anxiety levels among residents, particularly seniors who are already vulnerable.

Loss of Green Spaces: The erosion of natural environments reduces opportunities for restorative outdoor activities, negatively impacting mental well-being.

2. Noise Pollution

3. Air Quality and Respiratory Health

**Dust and Emissions:** Construction activities generate dust and particulate matter, exacerbating respiratory conditions such as asthma and bronchitis, particularly concerning for COVID-19 survivors with compromised lung function.

**Vulnerable Populations:** Seniors and individuals with weakened immune systems are more susceptible to respiratory infections and conditions aggravated by poor air quality.

4. Community Disruption

**Social Isolation:** The constant presence of construction discourages outdoor activities and social interactions, increasing social isolation among seniors who may already experience loneliness.

Access to Services: Construction activities disrupt access to essential services and amenities, creating additional stress and inconvenience for residents.

5. Lack of Transparency and Consultation

**Public Trust:** The lack of transparency regarding the planned Phase Two development undermines public trust. Residents feel deceived and marginalized, leading to feelings of helplessness and frustration.

**Informed Decisions:** Adequate consultation allows residents to voice their concerns and be part of the decision-making process. The absence of this process deprives the community of the opportunity to address potential health impacts proactively.
